Can you start from the beginning and tell me what you know about this murder.

A: Yes. It was between a year and two years ago. I was driving my sister's (Melody Bright) Lexis and Troy Stevenson was riding with me. Around midnight one night I received a phone call my sister's cell phone from Iris Bryant. She sounded real scared and nervous and asked me to hurry and come pick her up. About 30 minutes later I pulled into the hamburger stand at Two Notch and Chestnut and she was there alone where A she said she would be. She got in the car with me and Troy. She asked me to take her to the pool hall, the lounge on North Main. I asked her what is wrong. She said we robbed a man and I think we killed him. I told her, no yall had'nt done nothing like that. She said "me and my cousin, Tina or Tika shot him". She said he might be dead. I asked her how did she know he was dead and she said he was not moving. She said we got some money off of him and she pulled out a big roll of bills from her pocket and said, see here. She said it was about \$1000.00 and she said she and Tina split the money. She said it happened about an hour before she called me to come and pick her up. She said they shot him and took his money. I asked her how they got away and she said they ran through the woods to Interstate (I-20) and I can't remember if she said someone picked them up or they had a car parked near. She said it happened off Fairfield Rd. on a dead end street just across I-20. I found out later that morning the name of the street is Crawford. Me and Troy both asked her for some money and she would not give us any. She asked me to drop Troy off because one reason he kept telling her she was going to jail. I took Troy home at Crescent Manor off Two Notch Rd. above Pulliam Motors. Iris asked me to take her to the Social Lounge on N. Main Street. I drove her to the lounge and she got out and talked with Stevie B., her boyfriend. They went inside the lounge and she came back out a few minutes later and asked me to take her back to the hamburger place at Two Notch and Chestnut. At that time & Contradict Iris was living with her cousin (Tina or Tika) in the corner house on Branham Street and Chestnut. I don't think she wanted me to take her to her cousin's house because she didn't to give her cousin the idea that she had talked to someone about the robbery and murder. I dropped her off at the corner about 0230 to 0300 am and I went home.

About 0430 to 0500 am Iris called me again and told me to take her to the location and see if the car was still there. I thought she was lying about robbing and shooting someone so I told her I would take her. I picked her up again at the hamburger stand on the corner of Two Notch and Chestnut about 15 minutes after she called me. We drove to I-20 and went toward Fairfield Rd. We got off I-20 onto Fairfield Rd. exit. She told me to turn left of Fairfield Rd. and we drove about a block or two and she told me to turn right on the street which I found out later to be Crawford Rd. I drove almost to the dead end road and just before we got to the end of the road and she pointed to the right in woods and said, "that is where the car was". She was still nervous and I told her she was lying. We left there and she told me again that her and her cousin had robbed the man and he was driving a Mercedes. She said after he was shot he went forward to the steering wheel and the lights was still on and the horn was blowing. She said they made him think they were going to have sex with them and they were trying to find a good place to actually rob him. I took her back to the corner of Chestnut and Two Notch Rd.

O: Have you seen Iris or talked to her since taking her home that early morning?

A: Yes, many times.

Q: When is the last time you saw Iris?

A: At Renee Bostic's house on Howell Court about two years ago where I pointed out to you this morning. I have been in jail for about six months and did not see her for a while.

Q: What do you know about Tina or Tika, Iris' cousin?

A: I have only seen her about two times and the last time was a little after the murder. I have been to her house on Branham Street two times where I pointed out to you this morning. She is about 25 years old, short about 5' 3" and thick about 125 to 130 pounds. I do not know where she works at or anything else about her except that Iris calls her, her cousin and when I have seen the cousin I have seen Iris with her.

Q: You said that the Bostics', Lamont, Renee, Rita, and Alexander Sharpe (in jail on Fed charge) all know about the robbery and murder, how do you know this?

A: When I was Renee and Iris one morning about a month after the murder, Renee and Iris got in an argument and Renee told Iris she would call the police on her about robbing and killing the man and about the bad check charges she has on her. I also know that Iris asked me, Lamont Bostic and Troy Stevenson to go with them that night to rob the man. They knew who the man was but did not say his name. I thought they were just talking big.

Iris stays in Tiffany Gardens. I don't know the trailer, but it is in the back right. Steven B, be at the pool hall on N. Main, right across from the smile gas station. He has a powder problem, he tries to sell and use.

Q= What do you know about the other murder?

A=Lamont Bostic was in Fox trot with me. He was the one talking about it. He said Dirty Red Sum is Kevin Sumter, and Fred C, and another guy with dreads. I don't know who he is, but he hangs with those two. Lamont said that it was Dirty Red, Fred C and the guy with the dreads was the one who robbed the boy that fell threw the window. They did it because he sold drugs. Lamont said that it was those boys who tied that boy up and robbed him.

Q= How did Lamont know that?

A= they all grew up together from out of Henley Homes, and they are real tight. Dirty Red mentioned to me that that is what he does. Dirty Red has some boys, and when he catches wind of some dope, he will send his boys in to rob'em. I know Fred C and the guy with the dreads are two of them, but there may be two or three more. I have never seen Fred C or the dread guy. Lamont said that Tivo didn't have anything to do with it.
